TC Chamber of Commerce Foundation Funding Request - Live in Ithaca Project

Dominick Recckio of the Tompkins County Chamber of Commerce presented a request to help fund the Live in Ithaca Project, and on-line portal that will provide community resources and job openings in key sectors to attract workforce to the region. The total amount to get the project set up and running is \$100,000. Up to this point, \$50,000 has been committed by other private and educational institutions to support the project. The funding request to the TCDC is \$10,000.

John Guttridge disclosed that his business, Brightworks, provides IT services to the Chamber of Commerce.

Jennifer Tavares stated that this funding request is actually from the Chamber Foundation and that the contract with Brightworks does not include the foundation. She also commented that as the executive director of the Chamber of Commerce, she will not vote on this matter.

Martha Robertson moved to approve the funding request to support the TC Chamber of Commerce Foundation Live in Ithaca Project. Laura Lewis seconded the motion. The motion was approved 5-1-0 with Jennifer Tavares abstaining.
