Rich John called meeting to order at 2:05 pm.

Block 14 Funding Request - Approval

John Guttridge stated that he is on the board of directors of the Downtown Ithaca LDC II not for profit that is making this request. His involvement has been reviewed by council and while there is no actual conflict of interest, he will recuse himself as there may be a perception of a conflict.

Rich John stated that this funding request was considered last month and actually the board voted to approve but then decided to wait for full approval for submission of the legal document which has been done.

Jeff Gorsky made a motion to approve the Block 14 Funding Request. Ducson Nguyen seconded the motion.

Rich John stated that Dan Klein, Chair of the Tompkins County Legislature, sent him a text before the meeting and asked if the decision to approve the Block 14 funding could be delayed another month. Dan Klein would like to have the County weigh in on the decision with the TCDC Board. This is because the County owns one of the buildings on Block 14 and the final decision on the disposal of that building has not been made.

It was decided to keep the approval on the agenda this month.

Heather McDaniel commented that there is a need to clarify the payment option of the funding as the LDC is requesting three equal payments of \$30,000 each and clarification is needed on if this will be in advance or arrears. She asked that the term "monthly" be removed. This was seen as friendly to the motion.

A vote on the motion was taken. The motion was approved 5 - 0.
